STRATEGIC PLANNING & COALITION BUILDING

Social Services Review, Somerville, MA, 2021-2022. Conducted an internal review of four of the City of Somerville's departments that provide social services to residents. Consulted with about 25 staff members, analyzed findings, then produced a report directed to the incoming municipal administration compiling lessons from the intense period of social service provision during the pandemic.

Wildlife Conservation Society, New York, NY 2021. Conducted focus groups and strategic organizational thinking with some leaders about several strands of work by this non-profit focused on wildlife conservation globally and that manages an aquarium and several zoos locally. The initiative looked at how best to weave together related areas of interest and geography for the most impact.

This included planning with a small CBI facilitation team, conducting confidential interviews and designing an agenda meant to strengthen relationships and connections and enable participants to talk through some key company questions and get to solid, clear answers and a plan for the year.

This was followed a year later by a series of virtual sessions designed to review and update priorities and address timely leadership topics like succession planning.

The Welcome Project Visioning & Strategic Planning, Somerville, MA 2019-2021. At the first session, the board named key elements of their vision, and at the second, they made several key decisions about their essential areas of focus. CLIMATE CHANGE & RESILIENCE

New York State Climate Impacts Assessment, NY, 2021-present. Member of a four person CBI facilitation team supporting the State of New York in developing a report focused on likely climate impacts. The report is being authored by eight technical work groups, and the CBI facilitation team manages eight associated advisory groups of practitioners and academics. Tasks include providing strategic guidance, running virtual meetings of up to 80 participants, and co-leading an advisory group focused on ecosystems and one focused on society and economy.

Climigration Network / Community-led Solutions, Port Arthur, TX, Miami, OK and Playa de Ponce, PR, 2021-present. Member of a three-person CBI facilitation team supporting community-based organizations in three communities as they seek to learn more about what their local neighbors want to do in the face of increasing flooding from sea level rise (increase resilience? Relocate?). Working in

partnership with Buy-In Community Planning, the Anthropocene Alliance, JPB Foundation and the Lincoln Institute of Land Policy. Facilitate the 10-person planning team and help lead project-wide virtual meetings, including sessions with interpretation into Spanish. Project outcomes will include results from community surveys and identification of preferred strategies for moving forward.

Plum Island Economic Analysis for Sea Level Rise Decision Making, Newbury and Newburyport, MA. 2020-2021. Co-facilitated a collaborative research project funded through the Massachusetts Municipal Vulnerability (MVP) program. This included facilitating a community advisory group of stakeholders representing key local interests and leading public engagement over the course of the project. The project provided economic and fiscal data about the costs and benefits of providing services to the barrier island Plum Island in the face of coming sea level rise for use in future decision making by Newbury and Newburyport.

Cambridge Climate Change Preparedness and Resiliency Plan, Cambridge, MA, 2015-2021. Managed the public meetings (in person and virtual) and some of the stakeholder engagement for the city's effort to develop its first ever climate change preparedness and resiliency plan. This intensive planning effort outlined four focus areas: strengthening neighborhoods, enhancing buildings, improving infrastructure and greening the city. Final products will shape municipal investments and programs in coming years.

Somerville Climate Forward Ambassador Program, Somerville, MA, 2019-2021. Worked with the city's sustainability staff to develop and lead an education and relationship-building program for residents who want to better understand climate change and how they and others can make a difference at a local level. The program was run three times, in both virtual and in person formats. More than 100 residents have participated in the ambassadors program. Participants from continue to meet together to work on climate-related initiatives outside of the formal program or cohort they were part of.

Cape Cod Climate Initiative, MA, 2020. Co-led a facilitation team of 5 staff who managed four regional municipal committees, four topical committees looking at housing and development, natural resources, energy and transportation, and ran a series of focus groups with partner organizations on Cape Cod to assist the Cape Cod Commission to develop a regional climate plan addressing both greenhouse gas reduction and resiliency. The input from this stakeholder process shaped the plan approved by the Cape Cod Commissioners in January 2021.

Climate Resilience Zoning Task Force, Cambridge, MA, 2019. Co-led a 25-member multi-stakeholder committee including developers, residents, labor, environmental experts and city staff. With technical support, this committee developed and reached agreement on enhancements to city zoning that will increase climate resilience given future predictions of heat, precipitation and sea level rise.

Climigration Network, Cambridge, MA 2018-2019. Member of a team leading the Climigration Network, a community of practice on this the subject of helping communities consider managed retreat along with other adaptive options to protect from or accommodate changes in their environment due to climate change. Managed micro-grants provided to five initiatives funded in part through Climigration awards, and coached Climigration Network leadership setting up the network's work groups.

Cape Cod Climate Planning Opportunities, Cape Cod, MA 2019-20. Co-facilitated an information-gathering effort comprised of community meetings and focus groups during which the team gathered input on how the 15 municipalities on Cape Cod might jointly think about and approach climate change through the auspices of the Cape Cod Commission, the regional planning agency. Results included recommendations of process opportunities for consideration by the Commission.

Natural Resiliency Measures for Shorelines, New York State, 2015-2017. Supported the leadership team that working with several groups of staff members from New York State's Department of Environmental Conservation, Department of State, and other departments to jointly develop shared guidance on how more natural shoreline approaches could enhance the state's resilience to sea level rise, storm surge and flooding. This included planning and facilitation of regular team calls of up to thirty people, reviewing documents, and supporting project leadership, and was funded with support from the National Estuarine Research Reserve's Science Collaborative program.

Community Transformation at the Water's Edge, Boston, MA, 2015. Co-designed and helped lead a CBI-convened, day-long workshop about the challenge of discussing managed retreat from sea level rise at a community-scale. This workshop included 35 invited participants representing residents of coastal communities; grief and loss counselors; local, state and federal officials; artists; planners; and mediators. We explored why this option for responding to sea level rise is so often avoided and how it might be possible to better include it as one of the variety of possible local responses. CBI has formed a working group of participants who talk every two months to continue this dialogue and look for solutions.

Cambridge Climate Change Vulnerability Assessment, Cambridge, MA, 2012-2015. Lead facilitator for community engagement on a technical vulnerability assessment completed by climate scientists, engineers and public health experts for the city of Cambridge, MA. Planned and lead several 100 person+ public workshops and formal technical advisory committee meetings. This assessment will form the foundation of a Cambridge climate change preparedness plan.

Coastal Green Infrastructure, New York City, NY, 2014-2015. Worked with the New York Department of Environmental Conservation, New York City Department of City Planning and the New York-New Jersey Harbor & Estuary Program to develop an integrated, coordinated and prioritized strategy for tackling research needs related to coastal green infrastructure initiatives intended to improve resiliency in the New York City metropolitan area. The effort, which brought together federal, city and state agencies, research institutions and non-profits, involved a suite of confidential interviews and centered on a half-day workshop to plan for shared next steps.

Coastal Adaptation Scenario Planning, New York, NY, 2013. Supported an effort by the tri-state Regional Plan Association to develop tools that can assist municipalities, counties and regions to effectively select among adaptation approaches that will most effectively prepare them for climate change impacts.

Kingston Flooding Task Force, Kingston, NY, 2012-2013. With a team from the New York State Department of State and New York State Department of Environmental Conservation, planned and led a Task Force of local leaders, waterfront business owners, and people responsible for Kingston's key infrastructure to bring high level data to a local scale and help the Task Force develop adaptation recommendations to address substantial flooding from large scale storm events and future sea level rise. The task force has since been used as a model for three other town task forces along the Hudson.

New England Climate Adaptation Scenarios Project, 2012-2013. Part of a team that worked in Maine, New Hampshire, Rhode Island and Massachusetts to learn whether engaging a large and diverse group of people in a community in a simulation activity about climate adaptation increased local community focus on this important topic. Activities include working with four National Estuarine Research Reserves and a team of MIT graduate student researchers to learn about each community, design simulations, and lead community discussions. Early results indicate that one key lesson was that citizens were ahead of their local leadership in willingness to tackle these difficult topics.

New York Summit on Urban Coastal Resilience, New York City, NY, 2010-2011. Managed a year-long planning process and co-facilitated a day-long summit for invited participants from NY state agencies, New York and other cities, advocacy groups, economic development groups and others concerned with sea level rise. The group identified approaches for moving forward together on recommendations submitted by the NY Sea Level Task Force in December 2010.

Gender and Reducing Emissions from Deforestation and Forest Degradation (REDD), Washington, D.C, 2011. Facilitated a daylong strategic workshop for Oxfam America and partner organizations to produce an action plan among the major players interested in REDD+, gender and social safeguards across the globe. This workshop was held prior to several days of meetings and enabled participants to explore the potential impacts of REDD+ policies on women and relevant gender-differentiated roles; fair benefit sharing for women, women's access to decision-making, and more.

Cambridge Climate Congress and Dialogue, Cambridge, MA, 2009-2010. Planned and facilitated meetings among citizens of Cambridge and city staff and elected officials about climate policies and programs and opportunities for working jointly to more effectively decrease city-wide greenhouse gas emissions. Results included commitments from the city to fund an awareness campaign, focus on measurable goals, and work to be a model for those within and beyond city borders.

Making the Climate Connection, 2010. Assisted the Environmental League of Massachusetts (ELM) to determine the opportunities for building a network of groups focused on climate-related action across the Commonwealth. Co-managed an assessment in which 52 individuals across the state were interviewed to identify current activities and opportunities. Following the assessment results, ELM has convened the Global Warming Solutions Project, a coalition of groups working to support the state in implementing its commitments on greenhouse gas reduction.

Stakeholder Assessment for the State of the Carbon Cycle Report, 2004. Co-authored an early report detailing the concerns and hopes of over 30 individuals from around the United States regarding the creation of the State of the Carbon Cycle report. Presented the report to the team of people managing the production of the report at a two-day workshop for interested parties. The final report was released in November 2007.

COASTAL, OCEAN, AND ESTUARIES

Natick Dam Advisory Committee, Natick, MA, 2021-present. Lead facilitator of a two-person facilitation team working closely with town staff. Facilitating an 18-member multi-stakeholder committee formed to provide the Select Board advice on whether to remove a spillway and restore the Charles River or repair a dam and maintain the current impoundment area. The committee has met over 16 months and is in deliberations. It will submit its report to the select board, including a description of extensive public input, for the Select Board to make its decision. The committee has considered content including the Indigenous history of the place, the aesthetics and recreational use of the area, the ecological health of the river system, engineering considerations, financial implications, and liability and risk.

Offshore Wind Maritime Working Group, New York, 2018-present. Lead facilitator of a working group of experts on navigation and offshore wind in the New York – New Jersey Harbor area who are developing guidance related to navigation and offshore wind installation coming to New York. This role includes coordination among several state agencies, leading committee meetings and assisting in the development of work products that will help the state of New York learn maritime-related offshore wind lessons from other places.

Aquarium Conservation Partnership Planning, New York City, NY 2018, Boston, MA 2019, Washington, D.C. 2020 and virtually in 2020, 2021 and 2022. Planned and facilitated regular annual multi-day workshops for representatives from aquariums around the US jointly developing their national and state-level conservation policy. Participants in these meetings developed their workplans and list of cross-aquarium policy priorities, including plastics reduction, ecosystem protection, wildlife protection and climate change.

Mystic River Watershed Trash Free Initiative, Mystic River Watershed, Greater Boston, MA, 2020-2021. Facilitated a series of webinars and discussions for municipal leaders to bring focus to the issue of trash getting into the Mystic River and thus Boston Harbor and to identify strategies to reduce the problem. This series of discussions, hosted by EPA's Trash Free Initiative, led to the development of watershed-wide trash reduction priority projects that will be shepherded forward by the project collaborator the Mystic River Watershed Association.

Bringing Sustainable Fisheries to Scale; Reimagining the Fisheries Improvement Model, Seattle, WA, 2017. Planned and facilitated a two-day workshop for forty participants from around the world to explore key questions about how to strengthen and scale the fisheries improvement model used worldwide to enhance sustainable fishing practices. The meeting led to the formation of several working groups taking key topics forward for additional joint work.

Aligning for Impact; Wetlands Protection and Migration within the National Estuarine Research Reserve System, 2018-2020. Co-led the advisory committee and overall process for an 18-month effort to identify opportunities for the NERRS to coordinate and enhance their role in wetlands protection and migration in the face of sea level rise. The advisory committee included members from all over the US, and project products included 80 interviews, a lit review, extensive Reserve data collection, and recommendations for enhancing and deepening the reserve system's commitment to leading data collection and partnerships related to wetlands protection and migration.

Dams and Sediment in the Hudson River, Hudson Valley, NY, 2016-2020. Lead facilitator for a collaborative research project that studied what happens to sediments trapped behind dams when dams are removed. The multi-disciplinary team included modelers and ecologists doing field work. The CBI team managed overall project coordination and facilitated regular advisory committee meetings at which regulators, designers and local officials shared concerns and advice for the project. Project outcomes included field data from six impoundments, a classification of dams for predicting sediment release and models of sediment transport.

Owasco Lake Rules and Regulations Revision, Auburn, NY, 2019. Facilitated four stakeholder and public meetings to share the final draft of revised rules and regulations for Owasco Lake. A multi-stakeholder steering committee and extended staff working group spent several years developing new proposed regulations to reduce the number of harmful algal blooms in Owasco Lake. Public and stakeholder input was reviewed and considered by the steering committee before the final document was submitted for approval at the local and state level.

Hudson River Sustainable Shorelines Project, Hudson River Estuary, 2009-2018. Facilitated a decade-long collaborative research project led by the Hudson River National Estuarine Research Reserve to gather data on shoreline function and likely climate change impacts; engage broad stakeholders who own, design and manage shorelines along the Hudson River; and translate information about shoreline wellbeing and design considerations so it could be used by municipal and other decision-makers. This included coordination of numerous planning teams, advisory committees, technical committees, project management, reviewing draft documents, and facilitating all large-group meetings. Work products

included detailed mapping of physical forces in the Hudson, demonstration sites with more sustainable shorelines, peer-reviewed papers, white papers and a rapid assessment protocols for shoreline ecological and structural functioning.

Southeast Asia Fisheries and Aquaculture Initiative Policy Meeting, Bangkok, Thailand, 2018. Co-led a project led by the Monterey Bay Aquarium and the Carnegie Endowment for International Peace to gather input from fisheries and aquaculture leaders from around the world on how to best enhance sustainability in southeast Asian fisheries and aquaculture. We planned and facilitated an industry round-table hosted by Former Secretary of State John Kerry in Boston, then led a two-day workshop for forty participants who provided guidance on the most promising channels for progress in each of five Southeast Asian countries.

Bard Micro-Hydro Pilot Project, Hudson Valley, NY, 2017-2018. Assisted a team working to determine best methods for collaborative research around potential use of small dams for micro-hydro projects (very small hydro power installations). This included running a community meeting, assisting with overall project design, and leading a half-day on-site expert review with engineers and ecologists at a dam on the Saw Kill River.

Public Workshops on New England's Regional Ocean Planning, 2013-2017. Lead facilitator for a team of CBI facilitators who designed and facilitated multiple rounds of public workshops around New England for the northeast regional ocean planning effort. These meetings, located from Connecticut to downeast Maine, provided a variety of ways for the public to weigh in on the regional ocean planning work and development of the first ever Northeast Regional Ocean Plan (completed fall 2016). The team also led regular day-long meetings for up to 100 members of the public on relevant topics prior to the work of the formal decision-making body.

Offshore Wind Stakeholder Engagement, MA, 2017. Member of a CBI team of facilitators supporting Deepwater Wind in developing a robust community engagement approach in advance of submitting applications for an offshore wind project.

Northeast Coastal and Ocean Acidification Network, New England, 2014-2016. Supported a network of researchers, advocates, state and federal agency representatives and coastal industry representatives to design and lead a series of meetings with diverse stakeholders throughout New England. The day-long workshops were designed to gather input on a coordinated research and action plan for raising awareness about and taking action on ocean acidification, with one final stand-alone session on management options for coastal acidification. CBI produced all meeting summaries and a synthesis report capturing lessons learned.

Long Island Sound Blue Plan Stakeholder Engagement, Connecticut, 2015-2016. Worked closely with the CT-NY Bi-State Marine Spatial Planning Working Group to conduct an assessment by interviewing 25 key stakeholders in Long Island Sound and to develop an assessment report of their recommendations and interests related to the development of a marine spatial plan for Long Island Sound. Produced a document laying out options for how the formal Blue Plan Advisory Committee, which will be developing the Long Island Sound Blue Plan, might think about their various stakeholder engagement options.

Advancing Stormwater Solutions in Ohio, 2011-2015. Advised and facilitated the research team from the Ohio Department of Natural Resources, Old Woman Creek National Estuarine Research Reserve and watershed and stormwater management groups working to install and monitor green stormwater solutions in Ohio. Co-facilitated a collaborative learning multi-stakeholder group of 20 engineers and

state agency representatives guiding the project to ensure the results advance local stormwater practices. Led the final training for engineers and stormwater professionals from around Ohio.

Shoreline Habitat and Adaptation Dialogue, Hudson Valley, NY, 2009-2015. Facilitated an informal group of 15 environmental professionals from New York state agencies and environmental organizations as they shared their technical approach on key projects, sought each other's guidance, and coordinated efforts to ensure they were using the best approaches and focused on the most important habitat and adaptation issues. The quarterly meetings of this forum led to strong relationships and trust among colleagues with overlapping interest. Participants gave early feedback on important initiatives and served as a sounding board for mapping and other efforts along the shores of the Hudson.

Stormwater Best Practices Workshop, Huron, OH, 2015. With support from the National Estuarine Research Reserve Science Collaborative, planned and led a two-day workshop for leaders from several stormwater management projects around the country. The purpose of the workshop was to share best practices and lessons learned, and to identify possible activities that might benefit the NERRS program nation-wide in coming years.

Coastal Erosion Workshops, Massachusetts, 2014. Co-planned a series of five workshops throughout Massachusetts' coastal region to hear community concerns about coastal erosion. Facilitated three of these sessions. Worked with colleagues to produce a summary clearly synthesizing the opinions and hopes of the residents, which was submitted to Massachusetts' Coastal Erosion Commission.

New England National Estuary Program Finance Workshop, Boston, MA, 2014. Worked with the six National Estuary Programs (NEPs) in New England to explore creative opportunities to marshal resources in support of their long term local and regional objectives. Planned and led this two-day session, which became an opportunity for the NEPs in the region to identify resources and expertise that could be shared among their programs.

New England Marine Sector Engagement, 2012-2013. Co-led a process for the Northeast Regional Ocean Council, a six-state collaboration focused on regional ocean issues, to engage key members of three marine industry sector groups: aquaculture, energy and maritime commerce. Completed an assessment of issues and concerns for each sector, co-managed a large project team including researchers and five other facilitators, and organized eleven stakeholder working sessions, co-facilitating five. Input from these working sessions informed NROC members states and the New England Regional Planning Body's next steps on regional ocean planning.

Hudson River Restoration Project, NY, 2013. Assisted and facilitated state agencies and a coalition of environmental non-profits on the Hudson developing a partnership structure and effective process for a multi-year restoration planning effort. This effort result in an approach for developing a plan of shared priority restoration projects identified and agreed to by stakeholders in the region and adopted by the Army Corps of Engineers.

Coastal Priorities Workshop, Silver Springs, MD, 2011. Co-facilitated a two-day, eighty-person conference for state coastal program managers and NOAA staff to explore programs and services available to help states manage their coasts.

Regional Ocean Governance Forum, Monterrey, CA, 2010. Co-developed and facilitated a daylong policy dialogue for the Coastal States Organization (CSO) and the National Oceanic and Atmospheric Administration (NOAA) at CSO's annual meeting. 40 participants representing regions around the country and federal agencies identified current concerns, challenges and opportunities provided by the new National Ocean Policy.

National Ocean Assessment Policy Dialogue, Washington, DC, 2009. Co-designed and facilitated a two-day policy dialogue among federal agencies and state coastal zone managers to develop recommendations on how assessments of the coastline might work best in assisting states and federal agencies in their coastal management.

Massachusetts Ocean Partnership and the Massachusetts Oceans Plan, 2009. Member of the facilitation team for a planning and public engagement process for developing the Commonwealth's first ever oceans management plan. Facilitated small groups and provided meeting summaries from partnership and public workshops.

National Oceanic and Atmospheric Administration's North Atlantic Regional Team, 2009. Co-facilitator of a team of representatives from NOAA working to engage stakeholders proactively on five areas of importance in the North Atlantic; climate change, ecosystem-based management, coastal and ocean energy development, hazard resiliency, and integrated water resources.

Envisioning the Future of Coastal Management, 2007. Managed a yearlong, \$200K process for the National Oceanic and Atmospheric Administration and the Coastal States Organization to gather ideas from stakeholders across the nation of how to improve management of the nation's coasts and great lakes. Facilitated five 100-person meetings across the country plus three invitation-only two-day meetings of invited experts. Wrote detailed meeting summaries, trained volunteer facilitators, jointly managed a team of five, and organized all venues, refreshments and materials. Helped NOAA and CSO to develop cornerstones, core principles and options for a new approach to managing the nation's coasts through reauthorization of the Coastal Zone Management Act.

Stormwater Assessment, 2009-2010. Managed a team of three to conduct an assessment to determine the best way for the National Estuarine Research Reserve's (NERRS) Science Collaborative to support advancements in stormwater management through their funding and guidance to the 27 NERRs around the country. Interviewed 41 people including NERRS staff and other stormwater experts. The final report captured key challenges in stormwater management nationwide and opportunities for the NERRS Science Collaborative to consider and was used by the NERRS SC to decide where stormwater should fit within their key funding objectives.

Falmouth Wastewater Public Engagement, Falmouth, MA, 2010. Member of facilitation team managing a public engagement process to engage citizens in Falmouth city efforts to develop a plan to make a \$400m investment in improving wastewater management and receiving body water quality in coming decades.

Assabet River Assessment, Massachusetts, 2010. Staff member in a team of two that interviewed 25 people and drafted report summarizing findings from an assessment for EPA Region 1 about how to proceed with wastewater permitting with four towns along the Assabet River. Topics included primary types of contamination and opportunities for improving water quality.

Connecticut River Watershed Assessment, 2009. Team member in a group of three that interviewed nearly 50 individuals on key Connecticut River flow regime issues, and drafted a report describing findings and participant interest in engaging with The Army Corps of Engineers and The Nature Conservancy in an upcoming complex modeling effort to model the flow of the Connecticut River.

Maine Marine Assessment, 2007. Member of a team of two that interviewed 50 individuals along the Maine coast about their primary concerns and hopes for coastal and marine issues in the state and wrote an assessment report making recommendations for improving collaboration on primary challenges.

LAND USE, HOUSING, TRANSPORTATION, AND COMMUNITY DEVELOPMENT

Hudson Valley Affordable Housing and Conservation Strategy, Hudson Valley, NY 2022-present. With support from all participating organizations and The Nature Conservancy, leading a two-person facilitation team to help convene and facilitate a series of discussions among conservation and affordable housing groups in the Hudson Valley. Over 6-9 months, the group will look for opportunities to collaborate and support each other and to jointly make progress on issues of shared concerns.

Martha's Vineyard Housing Assessment, Martha's Vineyard, MA 2019-2020. How do people on the island of Martha's Vineyard see the housing situation? Led a facilitation team of two to conduct an in-depth assessment to gather community perspectives during which we spoke with 54 people through confidential interviews and focus group. The final product, a report delivered to the Island Housing Trust, a non-profit working to address housing needs on the island, will be used in the Island Housing Trust's strategic planning and shared with the public. The report outlined the extensive challenges to making homes and land affordable there.

Affordable Housing Collaboration, Greenville, SC 2019. Worked with board members from two entities helping to address the significant housing need through a series of confidential discussions. Over the course of four months and three six-hour meetings, we helped participants explore various ways they could collaborate or partner and helped get them to a final decision about seeking to move toward a housing coalition to jointly have wider impact.

Municipal Flooding Meetings, Somerville, MA 2019. Facilitated two public meetings for the engineering department of the City of Somerville at which staff reported on data collection and planning and members of the public shared their concerns related to neighborhoods that have seen frequent flooding for many years.

Traffic Safety Meetings, Somerville, MA 2019. Co-led a series of two contentious public meetings held to share the City of Somerville's plans for traffic calming, striping, and considering bike infrastructure on Powder House Boulevard, a wide mile-long street on which the city was wrapping up several years of infrastructure work. The first meeting had about 150 people, the second fewer. The facilitation team managed agenda development and helped structure the conversation so participants could give meaningful input, hear each other, and participate in a respectful, informative conversation.

Somerville-Tufts Partnership Agreement Community Engagement, Somerville, MA 2018. Conducted an assessment to learn residents' hopes and concerns about the partnership between Tufts University and the City of Somerville as captured in the partnership agreement between these two entities. Conducted an open public meeting, a series of confidential interviews and a survey which almost 100 people completed. Summarized all the input in a publicly available report.

Medfield State Hospital Master Planning Committee, Medfield MA, 2017. Led a volunteer committee that met bi-weekly, coordinating closely with the planning consultants, to help them develop a recommendation for reuse of a state hospital acquired by the town several years before. The technical meetings covered zoning, finances and urban planning in many forms. This committee eventually did reach agreement on a recommendation to submit to a town meeting for approval.

Envision Cambridge, Cambridge, MA 2016. Supported the consultant team that developed Cambridge's first ever comprehensive plan. This included planning for expert panels, public workshops, focus groups, and providing consultation on meeting materials and other engagement efforts being undertaken for Envision Cambridge in the first year of the project. It also included leading several focus groups for traditionally marginalized communities.

Coaching, CA, 2014-2015. Supported the planning director of a city in southwestern California in thinking through several land use conflicts over development projects. This included primarily one-on-one coaching, but also development and review of public meeting agendas and discussion of approaches for building trust and relationships in contentious situations.

North Kingstown Route 2/102 Visioning Process, North Kingstown, RI, 2011-2012. Managed an assessment in 2011 to explore stakeholders' issues, concerns and hopes for land use at the western Route 2 / 102 intersection. The assessment concluded that intensive process to develop a shared vision for the suburban/rural area could be productive. In 2012, created and led a 16-member appointed committee of community stakeholders to identify a solution to a conflict over future development of a parcel of land on the western side of North Kingstown. The committee met five times, held three large public workshops, and reached a consensus agreement on principles for the area that included recommended development density and characteristics.

Fresh Pond Shared Use Process, Cambridge, MA, 2010-2011. Co-managed and facilitated a public engagement process for the City of Cambridge to develop a Shared Use plan for Fresh Pond Reservation. Managed interactions with the public and a multi-stakeholder planning team, facilitating a series of eight evening public meetings to enable the public to articulate their recommendations for reducing conflict at Fresh Pond.

Fresh Pond Shared Use Assessment, 2010. Managed an assessment of approximately 30 users of Fresh Pond Reservation, one of the largest and best-loved open spaces in Cambridge MA. Interviewed stakeholders representing joggers, cyclists, dog-walkers and passive recreationalists, among others, drafted findings memo about options for decreasing conflict among users and assisted with development of a year-long public engagement plan on how to improve management of this public space.

Providence Waterfront Charrette, Providence, RI, 2008. Jointly designed and co-facilitated a public engagement initiative on waterfront redevelopment in Providence, RI. Co-facilitated eleven information and discussion sessions on a range of topics for up to 70 participants over four days to learn about and give input on the future and revitalization of the industrial waterfront.

Challenges and Opportunities for Amenity-Rich Communities in the West, 2007. Managed an assessment including 47 interviews and co-authored a report identifying opportunities for the Sonoran Institute to help regions in the western United States cope with challenges such as affordable housing, transportation, and the loss of the middle class.

Report on Western Opportunities for Regional Collaboration, 2006. With a team of three, interviewed stakeholders from eight regions in the western United States to identify opportunities for the regions to collaborate on conservation efforts with increased support by funders and technical experts. Completed a report summarizing our findings and recommendations for going forward.

Rethinking Urban Transportation Forums, Boston, MA, 2006. Facilitated four Boston Museum of Science forums for members of the public in which new transportation technologies were presented and up to 60 participants were invited to share their insights.

Pawcatuck Borderlands Regional Assessment, 2005. One of a team of three who interviewed members of the forested border region between Rhode Island and Connecticut to determine the extent of regional awareness, co-authored public assessment of the situation, and facilitated discussions at a presentation of findings.

Assembly Square Conflict Assessment, Somerville, MA 2003. With other CBI staff, interviewed over 40 stakeholders in a decades-long dispute over the development of a 143-acre parcel of land near downtown Boston. Wrote an assessment report that summarized findings and made recommendations, which was distributed to the municipal government and to all major players in the dispute.

NATURAL RESOURCE MANAGEMENT & FEDERAL LANDS

Forest for All NYC, New York City, NY 2021-present. Co-facilitate with a group of three other CBI teammates this new city-wide coalition working to protect and grow the city's urban forest. This includes co-leading an overall leadership group of 15 members and facilitating multiple action teams of up to 45 participants in monthly meetings as they work on policy, funding, stewardship, and broad awareness-raising for this important topic.

New York City Urban Forest Task Force, New York City, NY, 2019-2021. Co-facilitated an 80-person task force led by The Nature Conservancy. This 18-month process included managing four working groups plus a steering committee guiding the initiative and a five-person planning team. The task force developed an urban forest agenda for NYC to serve as a shared north star for organizations and agencies in the city working to ensure that the city's tree canopy is distributed where it needs to be, well cared for, and that it has the shared focus it needs to receive appropriate funding and support so it can benefit all New Yorkers.

Cape Hatteras National Seashore Off-Road Driving, Cape Hatteras, NC, 2008-2009. Helped successfully convene a 30-person Federal Advisory Committee Act negotiation to address highly controversial issues related to endangered species, recreational fishing, and off-road driving. Planned bimonthly regulatory negotiation meetings in a team of three facilitators, facilitated workgroups, drafted detailed meeting summaries, and worked with Committee members. The Committee's detailed work on a range of topics will be used by the National Park Service to develop ORV regulations for the Seashore.

Forest Collaboration, Maritimes, Canada, 2008-2009. Co-facilitated a group of environmental nonprofits and a large forest products company as they collaborated to identify joint projects and build relationships.

All-Terrain Vehicle Panel, Leominster, MA, 2005. Facilitated a four-person panel discussion on all-terrain vehicle use and open space management at the Trustees of Reservations' conservation conference.

Monomoy Wildlife Refuge Public Scoping Workshops, Chatham, MA, 2005. Facilitated small group discussions in large public meetings hosted by the Fish and Wildlife Service about the comprehensive conservation plan being developed for a wildlife refuge on Cape Cod.

Assessment of the Relationship Between Coastal States and the US Department of Interior (DOI), Washington, DC, 2011. Carried out an informal assessment of the strengths and weaknesses of the relationship between different DOI departments and coastal zone managers around the country for the Coastal States Organization.

Hathaway Pond Conflict Assessment, Rochester, MA, 2011. Interviewed 14 people and produced a summary report of findings about the Sippican River, Hathaway Pond, and perceived benefits and difficulties caused by possible dam removal.

Cape Hatteras National Seashore Negotiated Rulemaking Feasibility Report, 2005-2006. Co-authored extensive conflict assessment. Gathered information from almost 60 individuals about highly controversial issues related to off-road vehicle use, relations between the Park and the local community,

endangered species, recreational fishing and the opportunity for a collaborative effort to address these issues. Co-authored a report of findings and recommendations.

SUPERFUND AND TOXIC CLEANUP

Hudson River PCB Cleanup Community Advisory Group, Ft. Edward, NY, 2005-present. Facilitate a 25-member group of diverse interests providing input to EPA and General Electric on the implementation of the Record of Decision to dredge, dewater and transport Hudson River sediments contaminated with PCBs from the operations of two GE manufacturing facilities. Manage subgroups, run public workshops, and support EPA's engagement with this representative group of stakeholders.

Pease Air Force Base Restoration Advisory Board, Portsmouth, NH, 2016-present. Facilitate a 20-person group advising the Air Force on the cleanup at the former Pease Air Force base. In particular, focusing on water quality and concerns about per- and polyfluorinated alkyl substances (PFAS). Plan and facilitate quarterly meetings to share information, discuss community concerns, and hear from the public.

Mystic River Watershed Initiative, 2016-2022. Supported the Environmental Protection Agency (Region 1) and the many non-profit and agency members working collaboratively to clean up the water in the Mystic River Watershed. This included leading an in-depth collaborative effort to bring regulators, stormwater experts and municipal leaders together to share information and develop concrete stormwater workplans and helping to plan some steering committee or subgroup meetings, facilitating large events, providing meeting summaries and other neutral staffing support.

Community Engagement Assessment, virtual, 2021. Conducted an assessment of about 20 confidential community interviews for a large company working to clean up PFAS contamination and build relationships and communication channels. Provided process guidance given the input from the community.

Coaching, Washington, DC, 2020. Coached an EPA senior staff person working on pesticide approvals with evaluation and strategic plan development.

Risks and Benefits Associated with Consumption of Marine Fish, Boston, MA, 2008. Produce meeting summary on a day-long expert meeting hosted by the NIEHS Center for Environmental Health and the MA Department of Public Health in which researchers discussed the complexity of benefits and risks associated with eating fish, including PCB exposure and cardiac and other health benefits.

Massachusetts Military Reservation Plume Clean Up Team Review Summary, 2004. Interviewed members of a community advisory group to assess success of the group in meeting their needs on monitoring a superfund site cleanup of ground water plumes. Wrote summary report and created presentation of key findings.

AIR QUALITY

Greater Boston Breathes Better, 2004-2009. Co-facilitated and managed a region-wide coalition of US EPA and 40-member organizations including local governments, private organizations, and educational institutions working to reduce air toxics from transportation sources. Activities included engaging cities, towns, and universities in off-road construction retrofits, implementing no idling efforts around public schools, and working with local hospitals to reduce associated transportation-related emissions. Projects

leveraged obtained funded from the Boston Foundation, U.S. EPA, and the City of Boston and received one of 15 US EPA Clean Air Awards for 2008.

Fort Peck Environmental Health Campaign, Fort Peck, MT, 2007-2008. Support local agencies and communities on the Fort Peck reservation to identify opportunities for collaboration and skill development and to bring in outside resources to address environmental health concerns such as asthma and mold.

Boston Air Quality Working Group, Boston, MA, 2006-2008. Facilitated a group of academics, community advocates, and policy makers who met quarterly to forge relationships and jointly address local air quality concerns. Organized and facilitated two 40-60-person public symposia on the issue of improving collaborative efforts among these groups.

New England Radon Committee Assessment, 2007. Assessed the work of this committee of radon leaders in New England and provided recommendations for future action and collaboration.

OTHER FACILITATIONS, MEDIATIONS, AND ASSESSMENTS

West Virginia Education Listening Sessions, West Virginia, 2019. Led two of eight listening sessions around the state. These two meetings had a total of 400 people in attendance, with overall attendance at the set of listening sessions surpassing 1,000. CBI co-designed the sessions, which involved up to 20 small group facilitators leading discussions on specific topics and members of the public providing comments verbally and in writing for consideration by the state in the next legislative session.

B-Lab Champions Retreat Planning, New York City, 2018. Worked with a team developing a plan for a multi-day conference on B corps to identify key subject matter and topical content. This included interviews, review of a suite of materials, and facilitation of a day-long planning session.

Collaboration for Energy Volunteers, New Haven, CT, 2015. Developed and conducted a half-day workshop for people who lead voluntary greening efforts in Connecticut municipalities. This included general negotiation strategies as well as a focus on coalition-building approaches and tools.

New England Clean Tech Symposium, Boston, MA, 2012. Facilitated a summit for leaders from the clean tech industry convened by the Massachusetts Clean Energy Center and the New England Clean Energy Council. Participants explored challenges for clean tech sector development and identified shared priorities and workgroups for advancing joint objectives in the coming year.

Clean Energy Week Collaboration, Boston, MA, 2012. Assisted the Massachusetts Clean Energy Center to plan a meeting of the various organizations that organize Clean Energy Week to discuss successes and current challenges of a diversified and unstructured series of events and ways to work more closely together in the future.
