## SELECTED PROJECTS

### WATER, LAND AND ENVIRONMENTAL JUSTICE ISSUES IN HISTORICALLY DISADVANTAGED COMMUNITIES

#### **EPA/Colorado Smelter Superfund Site.**

Facilitates the Community Advisory Group (CAG) to ensure local residents are engaged with EPA and their state partner, CDPHE, in their management of the site, which includes a significant environmental justice focus. Mediates problem-solving within and among the federal and state government agencies, community stakeholders, and local jurisdictions to ensure the CAG is a productive stakeholder forum to discuss and address public health issues impacting historically marginalized communities within the Superfund site.

#### **BLM Stakeholder Assessment, San Luis Valley, Colorado.**

Over a nine-month period, worked with BLM to identify and interview over 50 Tribal, hispano, agricultural, recreational, traditional land use, municipal, county and other local representatives with an interest in BLM-administered lands in a rural, low-income area of southern Colorado with a significant history of environmental injustice. Developed an assessment highlighting Tribal and non-Tribal stakeholders' priorities, interests, and concerns for future BLM planning and protection of these lands; how parties wish to engage with the BLM in future efforts; and how BLM planning can address environmental justice. The assessment will inform the upcoming update to BLM's Resource Management Plan.

#### **Los Angeles Regional Water Quality Control Board MS4 Permit.**

Facilitated discussions among the Los Angeles Water Board, permittees and other stakeholders, including advocacy organizations and community environmental justice groups, to develop new regional stormwater permit for nearly 100 cities and counties in the Los Angeles metropolitan region, in the midst of on-going litigation with several key stakeholders over related permits. Conducted stakeholder interviews, drafted briefing memo with recommendations for convening the parties, and facilitated a high-conflict stakeholder workshop process to seek areas of agreement among cities, counties, environmental groups and regulators, reduce chances of litigation regarding the new permit, and address significant local environmental justice and community engagement concerns involving the new permit.

#### **Salton Sea Management Plan.**

Co-facilitated Advisory Committee process to help the State of California implement its 10-Year Plan to manage and protect the Salton Sea. The process involved highly complex legal, regulatory and technical issues; a web of institutional and community stakeholders; and crisis-level air quality and habitat issues. Worked with the State, local stakeholders and a Salton Sea Community Engagement

Committee to address, in particular, the public health opportunities for, and meaningful engagement with, low-income communities near and along the U.S.-Mexico border.

**WRAP Integrated Water Resources Management Planning (San Antonio River, TX and Verde River, AZ), River Network and EPA's Office of Water.** Co-facilitated a national assessment to better understand how integrated water resource management could be applied through an equity lens to benefit under-resourced communities, with pilot locations in San Antonio and Arizona's Verde River watershed. Developed and facilitated an equity and engagement process for the Urban Waters Partnership in San Antonio to explore the use of equity mapping and community-based processes to integrate water projects to serve historically disadvantaged communities. Highlighted learnings for River Network, EPA and the National Park Service in their work to promote integrated, locally informed, equity-focused water management throughout the country. **EPA Urban Waters Partnership Program (NM).**

Facilitated workshops in Albuquerque to build collaboration among federal agencies administering programs in the Middle Rio Grande corridor and members and leaders of low-income communities and Tribes directly impacted by federal projects. The workshops addressed specific barriers to robust public participation in the NEPA process for each project and resulted in development of a strategic outreach plan for agencies working in Albuquerque's South Valley communities on issues of environmental justice.

**Science Based Water Target Network, Alignment of Corporate Guidance.** Designed and facilitated a process for the Science Based Target Network's Freshwater Hub, and members including Water Resources International, The Nature Conservancy, World Wildlife Fund, Alliance for Water Stewardship, and Pacific Institute, to jointly articulate a common framework and corporate guidance for water target-setting. Over the two-day workshop in Washington D.C., organizations shared perspectives, agreed on collective priorities and strategies, and integrated their approaches into a shared overall roadmap for corporations to follow in developing and implementing science-based freshwater targets.

**CLIMATE, HOUSING AND EQUITY**

**City of Denver, Waste No More Task Force.**

Facilitates a 26-member Task Force charged with developing implementation recommendations for a voter-passed zero waste ordinance with a focus on climate equity and environmental justice. Conducted an assessment to frame the 9-month Task Force process made up of commercial and multi-family building representatives, waste haulers and processors, construction and demolition companies, compost and recycling advocates, unions and other key stakeholders. The Task Force will produce its recommendations in late 2023.

**City of Aspen, Decarbonization Building Performance Standards Advisory Committee.**

Facilitates a 25-person committee of stakeholders helping Aspen decarbonize its building stock by 2050, with a focus on supporting less resourced buildings, preventing further displacement, transitioning the work force with good local jobs, and setting a standard that can inspire others and be replicated elsewhere.

**Energize Denver Task Force, Denver Office of Climate Action.**

Facilitated a complex, fast-paced Task Force effort to electrify Denver's 17,000 existing buildings and transition them to net zero energy by 2040, while prioritizing benefits for historically disadvantaged neighborhoods. Structured and facilitated monthly Task Force meetings, with several Work Groups and consultant teams providing regular decision-making input, tools and analysis, including on equity mapping and workforce development. The Task Force adopted its ground-breaking consensus recommendations in August 2021.

**New Mexico Climate Task Force.**

Through the U.S. Climate Alliance, in 2020 helped the State develop a stakeholder engagement plan to guide the State's Climate Action Planning. Building on that work, was engaged by the State in 2021 to help design and facilitate a Climate Action Task Force to guide New Mexico's climate planning, with a strong focus on meaningfully engaging BIPOC leaders and prioritizing communities of color in climate planning, adaptation and mitigation.

**City of Denver Accessory Dwelling Unit (ADU) Advisory Committee.**

Facilitated an Advisory Committee comprised of City Council members, housing advocates, neighborhood associations, architects, and other Denver stakeholders to help the City address and remove barriers to building ADUs. The effort was designed to increase housing stock in Denver, with a focus on more equitable and affordable housing. The Committee's work will result in an amendment to the Zoning Code in 2023.

**COP26 Climate Risk Assessment 'Lessons Learned' Workshops.**

With the Woodwell Climate Research Center, co-facilitated country-specific workshops to prepare for the 2021 U.N. Climate Change Conference (COP26) in Glasgow. Led participatory discussions among country experts, ranging from China to Argentina, to provide input to COP26 Presidency on the most effective ways to deliver climate risk information to policy and decision-makers, based on lessons learned from a variety of countries.

**E-Lab Clean Energy Transition 'Accelerator' (ZOMA).** Worked with ZOMA and RMI to adapt the Rocky Mountain Institute's E-Lab Accelerator framework to a CBI-facilitated clean energy accelerator event in Chile.

**COLLABORATIVE APPROACHES TO WATER RESOURCES MANAGEMENT AND CONFLICT IN THE WESTERN U.S.**

**Yampa River Integrated Water Management Plan (CO).**

Facilitation and process design support to the Yampa-White-Green Basin Roundtable and its IWMP Committee, comprised of over 25 members representing a highly diverse set of local governments, agricultural representatives, conservation groups, water districts and other stakeholder interests. Facilitated effort to clarify the purpose, need, and sideboards necessary to implement an IWMP for the Yampa River, and co-facilitates Committee decision-making based on extensive recent data and stakeholder assessments. The Committee is developing multi-benefit projects to advance Basin goals with support from River Network, Walton Family Foundation, The Nature Conservancy, Colorado River District, and others.

**California Bacteria Summit.**

Working with the State Water Board and statewide stormwater association to design and facilitate a three-day stakeholder summit to look for ways to more effectively regulate water quality risks regarding

swimming and shellfish consumption in California. The Summit will bring together both regulators and regulated entities, as well as environmental advocates, academics and other experts, to look at the latest science on harmful bacteria and collaboratively explore achievable approaches to ensuring waters are safe to swim and shellfish safe to eat.

**Ogallala Aquifer Summit/Coordinated Agriculture Project.**

In 2018 and 2021, facilitated a 2-day groundwater summit of hundreds of water policy leaders, managers, and irrigators/producers in the 8-state Ogallala Aquifer Region focused on groundwater declines and agricultural sustainability. Outcomes included identifying and prioritizing state-based approaches and best practices for managing the aquifer; next steps for intra- and inter-state management and policy options conducive to sustaining agriculture and the well being of communities within the Ogallala aquifer region; and science/data needs and outreach approaches that enable producers and policy makers to achieve greater conservation and water use efficiency goals.

**North Platte Natural Resources District Strategic Plan.**

Worked with Board and staff over six months to refine future goals and objectives for the District in order to address increasing groundwater scarcity and water quality challenges. The District is submitting its statutorily required Master Plan update to the State of Nebraska in 2022.

**Upper Roaring Fork River Integrated Water Management Plan (CO).**

Facilitated a multi-stakeholder coalition of local, state and federal government, irrigators, NGOs, recreational groups and others to provide recommendations to Aspen and Pitkin County regarding river management alternatives. Conducted an assessment to understand key issues, opportunities and constraints, to help inform the process and approach in light of complex legal and policy conflict affecting future river operations. Worked with the coalition to study the river system, community priorities, regulatory and legal issues and constraints, feasible management options, and trade-offs in river management and restoration alternatives, and to vet, prioritize, and recommend options for the City and County's consideration.

**Big Thompson Watershed River Envisioning Project (CO).**

In 2019-2021, provided facilitation to a multi-stakeholder Advisory Committee to develop an integrated plan for the Big Thompson River to meet the long-term needs of local communities, including towns, businesses, recreators, and irrigators, while securing the future health and resilience of the river and its resources. With a technical team of scientists and engineers, helped the BTWC and Advisory Committee integrate a data-driven river assessment with an in-depth stakeholder assessment of interests, values and needs for the Big Thompson River.

**Clear Creek Integrated Water Management Plan Steering Committee (CO).**

After conducting a stakeholder assessment, facilitated Committee discussions to identify the goals and parameters for watershed-wide collaboration on Clear Creek. Goals include the increased alignment of projects and ongoing identification of watershed needs, to address environmental, recreational, stormwater, water quality, transportation, industrial, agricultural and other interests in the river.

**Coalition for the Poudre River Watershed Fish Passage Pilot Project (CO).**

Provided facilitation to support partnerships between the Coalition and local ditch companies to upgrade critical diversion structures in the Poudre River downstream of Fort Collins with river-friendly fish passage structures, as pilot for other locations in Cache la Poudre River.

### **Yampa-White-Green Basin Implementation Plan Update (CO).**

With a technical team, facilitated the Basin Roundtable's current BIP update. Facilitated a 25-person stakeholder committee charged with refining Basin goals and objectives in light of current challenges, vetting a list of current and anticipated Basin projects in light of State criteria, identifying gaps in technical information that need further exploration for Basin planning, and developing an updated BIP for the Roundtable's approval.

### **City of Fort Collins Poudre River Integrated Management Workshop and River Health Assessment Framework (CO).**

Mediated discussions among the Utilities, Stormwater and Natural Areas departments to align their water supply, flood protection and river health priorities in managing the Poudre River. Staff identified and agreed upon guiding principles, relative priorities and next steps, including strategies for integrating water supply projects, storm-water management, and river health initiatives. Ryan then facilitated an internal effort to collaboratively develop a River Health Assessment Framework to quantitatively define the City's vision for a healthy and resilient Poudre River. The tool has been used for State of the River Reports and to evaluate the river health impacts of internal and external projects.

### **City of Fort Collins 'River Flow Negotiations/Lessons Learned' Workshop (CO).**

With the City's leadership, Ryan co-designed, organized and facilitated a workshop with partners to explore, discuss and build understanding about lessons learned for engaging in negotiations concerning flow regimes.

### **Water Resources Plan Workshop, Metropolitan Water District of Southern California.**

Co-facilitated workshop involving hundreds of participants to share information, receive input and discuss strategies related to the District's updated Integrated Water Resources Plan. Participants included member agencies and jurisdictions, elected officials, water managers, non-governmental organizations, private industry, academics, and community stakeholders. Navigated the tension of soliciting meaningful input in a process that involved significant technical and policy challenges, significant conflict, a severe drought, and resources central to millions of people's lives.

### **Left Hand Creek Watershed Master Plan (CO).**

Facilitated a 25-member Coalition of local, state and federal agencies, water districts, and community stakeholders tasked with developing a master plan for the Left Hand Creek watershed in the wake of the 2013 floods. Managed and facilitated the oversight and collaborative problem-solving work of the Coalition. In close coordination with a technical team of scientists and engineers, planned and facilitated the public engagement process for hundreds of private and institutional stakeholders to provide input and buy-in into the watershed master plan.

### **Fourmile Creek Watershed Master Plan (CO).**

Co-facilitated a County task force to develop a master plan for Fourmile Creek, working closely with Engineering team and project partners. The project led to extensive public engagement and meeting facilitation for Boulder County during its concurrent processes of watershed restoration and controversial road-rebuilding through Boulder's Fourmile Canyon.

### **Colorado River District Strategic Planning.**

Worked with staff and Board to refine the District's strategic priorities for protecting, optimizing, and advocating for Colorado's western water. She worked closely with staff and Board members from 15 diverse counties to develop a plan for the District that would address the often-competing interests in

conserving, developing and advocating for water in Western Colorado. Through individual interviews and a two-day workshop, she worked with the Board to understand the needs of each sub-basin while aligning its vision and priorities for the basin as a whole.

**Upper Yampa Water Conservancy District Strategic Planning, Collaboration Training and Board Governance (CO).**

Worked with the District to facilitate Board retreats, train staff in collaboration and facilitation, and conduct an assessment in 2019 to better understand stakeholder needs and priorities. Facilitated the development of a board governance policy manual as well as a strategic plan to guide the District in near and long-term operations and planning for controversial future projects.

**City of Aspen Long-Range Water Supply Study (CO).**

Conducted assessment and process design for collaborative effort to study future water supply and demand under a range of climate scenarios, in context of contentious litigation and planning challenges. Interviewed 35 stakeholders including federal, state and local land and water management agencies, conservation groups, regional water management entities, jurisdictions, local landowners, and many others. Produced report with findings and recommendations for collaborative planning process in 2017.

**Colorado Department of Transportation Storm Water Task Force.**

Co-facilitated a statewide Task Force charged with developing consensus recommendations for new policies and procedures consistent with state and federal regulatory requirements. Worked with Task Force to anticipate, understand, and mediate areas of conflict among different regional and headquarters offices.

**CWCB Technical Update (CO).**

Provided facilitation support to the Colorado Water Conservation Board and other stakeholders to update the SWSI, a technical analysis of state water supply and demand forecasts, in support of Colorado's newly drafted and first-ever Water Plan. The process involved a large technical team working with the State and stakeholders to identify Colorado's current and future water needs, as well as potential approaches to meet those needs.

**Water Savings in Performance Contracting, Western States Peer-to-Peer Exchange.**

Helped design and facilitated workshops for Western Resource Advocates and the State Energy Offices of Colorado, Nevada, New Mexico and Arizona to develop strategies to accelerate water savings measures in state performance contracting in the Colorado River Basin states. The process identified key gaps the states wish to address and priority next steps, including collaborating with partners, identifying funding sources, and developing best practices guidelines along with potential state-level policy changes.

**Colorado Energy Office Produced Water Policy Dialogue.**

Co-facilitated a multi-stakeholder effort to identify interests and barriers to the reuse of produced water from oil and gas operations. Interviewed 30 stakeholders and designed and co-facilitated a one-day dialogue with 65 stakeholders from across Colorado, including energy companies, state regulators, federal agencies, NGOs, attorneys, counties and others. The dialogue focused on potential opportunities, key challenges, and next steps for exploring the re-use of produced water. Co-drafted a white paper for the Energy Office to frame the issues and recommend next steps to lawmakers, industry groups, NGOs, and educational and policy institutions.

### **Douglas County Water Permitting Mediation.**

Mediated large dispute on Colorado's Front Range involving the future of a long-standing water system in a large, unincorporated area of Douglas County. This involved gathering and synthesizing information from a diverse array of State, County and private sources, building dialogue and identifying common interests among the diverse stakeholders, identifying and evaluating options, and working to develop a plan for a future water supply system.

## **COLLABORATIVE APPROACHES TO LAND MANAGEMENT, LAND USE AND ENERGY**

### **BLM Travel Management Planning, Southwest Colorado.**

Facilitated a pre-NEPA stakeholder assessment and community meetings to explore how upcoming planning for a remote system of BLM trails and roads could support regional economic development and recreational goals in low-income, rural communities transitioning off coal and uranium mining in Dolores, Miguel and Montrose counties.

### **Browns Canyon National Monument (BCNM) Planning Assessment Process (CO).**

Co-facilitated a stakeholder assessment process for the BLM and U.S. Forest Service, which are jointly charged with managing BCNM in southern Colorado. The process involved designing and facilitating in-person listening sessions, stakeholder interviews, and an overall stakeholder assessment to inventory human views and values regarding the area. Project culminated with a Social Landscape Assessment to guide future NEPA scoping and planning for BCNM.

### **City of Boulder Open Space and Mountain Parks Community Engagement Framework.**

Facilitated a multi-disciplinary team working with the City to develop a framework to guide its engagement of visitors on its extensive public lands. The first-of-its-kind planning framework will guide City decision-making regarding services, programs, associated infrastructure and media for engaging community members in each site, with a strong focus on ensuring benefits and access for low-income residents and visitors.

### **EPA/Lowry Landfill Superfund Site (CO).**

Mediated highly controversial groundwater contamination issues among EPA, State of Colorado, and the potentially responsible industry parties (PRPs) in managing the Lowry Landfill Superfund site. Conducted an assessment to convene a Community Advisory Group (CAG), and for three years facilitated the CAG to provide input to EPA and the State in overseeing the site, including an effort to engage historically disadvantaged communities in the surrounding area. Worked with community stakeholders, government agencies, local districts and jurisdictions, and industry to ensure the CAG met the needs of the group's diverse stakeholders in discussing and providing input regarding groundwater concerns at the site.

### **Assessment of Colorado Oil and Gas Community Agreements.**

Facilitated a stakeholder effort to assess the effectiveness of MOUs as a tool to address oil and gas development disputes in Colorado, with a focus on air and water quality issues and BMPs. This involved a series of stakeholder interviews and white paper, as well as a repository of MOUs negotiated between producers and communities. The process focused on challenges, opportunities and learnings from communities, regulators, industry and others in using MOUs and similar instruments to address community impacts.

**Oil and Gas Regulatory Review Process (CO).**

Co-facilitated a process to gather public input on the City of Thornton's proposed draft ordinance to regulate oil and gas development, including detailed new areas of air and water quality regulations. The process focused on designing and facilitating a community meeting to provide information, respond to concerns, and solicit input from residents, conservation groups, oil and gas companies, attorneys, state regulators and others concerning the current draft of this proposed and highly controversial ordinance.

**Mediation of Arapaho and Roosevelt National Forest Forsythe II Objection Resolution Process (CO).**

Mediated process involving controversial Environmental Assessment and Draft Decision Notice involving 30 objections from individuals, groups and agencies, regarding controversial forest plan and its implementation in the wake of significant floods and wildfires. Conducted interviews and facilitated a problem-solving workshop involving objectors and the National Forest to address areas of concern.

**Earth Day 50 Challenge (Future 500, Dallas TX).**

Provided facilitation support for Earth Day Challenge, bringing together nearly 100 environmental, corporate and philanthropic leaders in a national collaboration to protect the world's oceans, forests, and climate.
